Motion to appoint Miranda Van Santen as Treasurer for a two year term. (Frank/Anderson) Motion carried unopposed. Cox administered the Oath of Office to Van Santen.

Motion to transfer \$10,000 from the Underwood money market account to the checking account. (Frank/Anderson) Motion carried unopposed.

Fire Department: All DOT certifications have been completed. Nothing further to report.

Road Report: John Christenson reported on the condition of Statesboro Drive and the non-township portion of the road. Discussion regarding the grading of non-township roads if needed for public welfare and safety.

Bengtson reported that 385th Street can be reopened. Discussion regarding drainage issue on Alberg Road.

213th Street (zoning delineations): Discussion regarding commercial district boundary at 213th Street. Motion to define and set the south border of the commercial district at 1100 feet from the centerline of Highway 210, from 380th Avenue to the center of Section 5 west of 365th Avenue. (Anderson/Frank) Motion carried unopposed.

Open Forum for Public Comment: Resident raised concerns about plowing and the amount of gravel in the ditch on Antler Lane.
